ADMISSION CRITERIA FOR PROGRAMMES TUITIONED IN ENGLISH 2025

General information related to the First Joint Application for Higher Education of Spring 2025 and SAMK's Separate Application, SAMK Admission Spring 2025

Later in this document you will find more specific information of each application.

All the schedules, times and dates in this admission criteria are announced in Finnish time.

Application period

In spring 2025 Satakunta University of Applied Sciences (SAMK) takes part in joint application for higher education and has a separate application of their own. Both the Joint Application, Spring 2025 and SAMK's separate application SAMK Admission, Spring 2025, will take place on 8 – 22 January 2025 (the application period ends on 22 January 2025, at 3:00 p.m. Finnish time). The joint application and SAMK's separate application have separate application forms.

If you are offered study places from the joint application, the separate application of SAMK or any other application of a Finnish higher education institution, you are allowed to confirm one study place only, for studies starting in Autumn 2025 in a Finnish university or university of applied sciences.

Eligibility for Bachelor's degree programmes in joint application and SAMK's separate application

Provisions on eligibility for universities of applied sciences are contained in the Polytechnics Act (932/2014).

You can apply to a Bachelor's degree programme if you have completed:

- the studies required for graduating from the Finnish upper secondary school or a Matriculation Examination;
- an International Baccalaureate (IB) degree and/or graduated from IB high school with IB exam 6 results in different subjects (IB-certificate);
- a European Baccalaureate (EB) Diploma;
- Reifeprüfung (RP) or Deutsches Internationales Abitur (DIA) degree;
- a Finnish vocational upper secondary qualification covering 120 credits or 180 competence points or a corresponding earlier Finnish vocational degree covering at least 80 credits;
- a Finnish post-secondary or higher vocational level diploma;
- a Finnish vocational upper secondary qualification or a further or specialist vocational qualification as a competence-based qualification, or a comparable previous qualification;
- a foreign qualification that provides eligibility for higher education studies in the country in question or
- a Finnish or foreign higher education degree

Applicants must submit proof of their education according to the deadlines given in the application form.

Proving eligibility

Applicants must have completed the qualification used in the application procedure in time for a copy of the certificate to reach Satakunta University of Applied Sciences by the deadline specified in advance following the publication of admission results (see the Schedule Appendix).

Applicants need to attach a copy of the certificate/the final graduation diploma on their application by the deadline specified in advance (see the Schedule Appendix) if they have completed any of the following education:

- Finnish Vocational upper secondary qualification completed before year 2017
- Finnish Further or Specialist Qualification completed before year 2018
- Finnish Matriculation examination completed before year 1990
- Finnish upper secondary school syllabus
- Finnish vocational upper secondary qualification completed in Åland
- International Baccalaureate (IB) diploma, European Baccalaureate (EB) diploma or Reiferprüfung (RP)/ Deutsches Internationales Abitur (DIA) diploma
- Higher secondary school certificate completed outside Finland (e.g. high school diploma)
- Bachelor's degree, Master's degree, postgraduate licentiate and doctoral degrees completed outside Finland

In addition, each applicant must submit a copy of their qualification certificate(s) translated into Finnish, Swedish or English by an official authorised translator if the original document is in none of these languages. Such translations must be signed and stamped by the translator. The translations must be saved to the application form by the deadline specified in advance (see the Schedule Appendix).

If you are a refugee or in refugee like situation and cannot submit documentary evidence of your qualification, you can submit a copy of the decision on asylum or a residence permit granted on the basis of a need for protection. Document must be delivered to the Admission Services of your first choice by 29 January 2025.

Graduating during or after the application period

Those applying to a Bachelor's degree programme, who complete their qualification during or after the application period (at latest by the deadline given in the Schedule appendix) are required to attach an official document about their graduation on the application form.

If you are completing your upper secondary education OR a bachelor's, master's, postgraduate licentiate or doctoral degree outside Finland in spring 2025, attach a transcript of study records or other certificate provided by the learning institution that states the degree/qualification you are completing to your application latest by Wednesday 29 January 2025 3 p.m. Finnish time. It should also state the scope of the degree and estimated date of graduation. The certificate should be provided with the official stamp of the educational institution and must be signed and clarified by an educational institution representative including a representative's title.

If you are completing any of the following International Matriculation examination in spring 2025:

If you are completing your IB Diploma/EB Diploma education in the spring 2025, attach a transcript of study records (Predicted Grades) or other certificate provided by the learning institution that states the degree/qualification you are completing to your application at latest by the deadline given in the Schedule appendix. It should also state the scope of the degree and estimated date of graduation. The certificate

should be provided with the official stamp of the educational institution and must be signed and clarified by an educational institution representative including a representative's title.

If you are completing a DIA degree in the spring 2025, attach a copy of the final graduation certificate which states the final grades to your application at latest by the deadline given in the Schedule appendix.

If you are completing a vocational upper secondary qualification in spring 2025 in Åland, attach a certificate to your application form at latest by the deadline given in the Schedule appendix in order to be taken into account in the certificate-based student selection. Certificate must contain the following information: final parcial performances, weighted average grade and confirmation of graduation.

Note! If you are accepted as a student and completed any of the following education in spring 2025 you need to submit the certificate/final graduation diploma to your application by 10 July 2025 by 15.00 (UTC/GMT +3)

- Finnish general upper secondary school syllabus: The final graduation certificate
- Finnish vocational upper secondary qualification completed in Åland
- EB diploma
- IB Diploma Programme (DP) Results
- DIA diploma
- Higher secondary education outside Finland: The final graduation certificate and its official translation
- Bachelor's, Master's, postgraduate licentiate or doctoral degree completed outside Finland - The final graduation certificate and its official translation

Applying through discretionary admission

SAMK doesn't have discretionary admission, i.e. the possibility to apply without an eligible background education, to its degree programmes.

Application period

In the Joint Application, Spring 2025, you can apply up to six (6) degree programmes available in the application period with a single application form. The programmes do not have to be listed in any order of priority. SAMK will offer selected Bachelor's degree programmes in the joint application for higher education. The results of the student selection are announced according to the schedule given in the descriptions of student selection. Applicant is required to confirm the offered study place at latest on 10 July 2025, at 3.00 p.m.

Evidence of language proficiency as part of admissions

Finnish language test

SAMK doesn't organise a Finnish language test or require result of any Finnish language test for admission.

English language proficiency

Good skills in English are required for success in degree programmes provided in English.

Proof of English proficiency is required in all the available degree programmes in SAMK.

The applicants must demonstrate their English language skills by means of a language test or previous studies, in order to be invited to the International UAS Exam and to be selected through the International UAS Exam. More detailed information on language requirements is available on the UASinfo.fi website.

Demonstration of language skills in the certificate-based selection for study programmes conducted in English:

As of the first joint application in spring 2025, applicants who have completed the Finnish matriculation examination or international matriculation examination must demonstrate their knowledge of the English language by means of a separately defined previous qualification, part of a qualification or a separate language test. More detailed information on language requirements is available on the UASinfo.fi website.

Identification of the applicant

The applicant needs a valid, acceptable identification document. The following documents are accepted as proof of identity:

- a passport, the passport can be either biometric or non-biometric
- a biometric identity card from an EU/EEA country
 - if you do not have a passport but you have a biometric identity card from an EU/EEA country, it is accepted as proof of identity
 - note: the EU/EEA identity card must have a biometric symbol

No other forms of identification documents are accepted. For example, residence permit cards or non-biometric EU/EEA identity cards will not be accepted. Use the same identification document through the whole application period.

You must be identifiable from the photo on your passport or identity card. Note this especially if it has been a long time since the passport or identity card was issued.

The passport/biometric identity card from an EU/EEA country must be valid until 20 March 2025.

Accessible student admission – individual arrangements for entrance examinations

If, due to disability, disease, dyslexia or some other specific reason, you need individual arrangements during the entrance exam of the first joint application in spring 2025 (e.g. additional time, tasks without pictures for applicants using a screen reader), you have to fill in a written request for individual arrangements. Please attach a medical certificate or other equivalent attestation on the nature of your disability or disease. The statement should clearly state why you need individual arrangements and explicitly detail the type of individual arrangements recommended for you. The applicants' situations are assessed on a case-by-case basis.

The request for individual arrangements, with the necessary attachments, must be submitted by **29 January 2025 at 15:00 Finnish time (UTC/GMT+3)** to the Admissions Services of the university of applied sciences using the International UAS Exam that is highest on your application form.

Student selection – Degree Programme in International Business, Rauma; Degree Programme in Logistics, Rauma; Degree Programme in International Tourism Management; Degree Programme in Mechanical Engineering; Degree Programme in Artificial Intelligence (Data Engineering); Degree Programme in Mechatronics

SELECTION METHOD 1: CERTIFICATE-BASED SELECTION, FINNISH MATRICULATION CERTIFICATE AND IB, EB & RP/DIA COMPLETED IN FINLAND

Applicants applying with a matriculation examination (Finnish or international completed in Finland) have their own quota of study places which varies between study programmes available for application.

All universities of applied sciences comply with the scoring models and principles of certificate-based selection.

The universities of applied sciences may determine, in the certificate-based selection, a minimum score and/or other threshold criteria for their study programme available for application.

Finnish matriculation examination:

In certificate-based selection, five subjects are scored. All scored subjects are taken into account only once. The best combination of scored subjects to the applicant is taken into account. Maximum score is 198 points.

The scoring model of the Finnish matriculation examination is available on the UASinfo.fi website.

Equal score rules

If two or more applicants share the same total score, the rank order of applicants is resolved according to the following equal score rules:

1. Order of preferred study programmes
2. Matriculation examination grades:
 - I. Native language
 - II. Mathematics
 - III. Foreign language/second national language

If, for example, two applicants have received 100 points each and they both have the same order of preferred study programmes, the applicant with the better grade in native language will be selected. If both applicants have the same grade in native language, the second subject on the list is taken into consideration.

3. Overfilling/underfilling/drawing lots

If the criteria fail to produce a difference between tied applicants, SAMK admits all of the equally ranked applicants. SAMK may cancel admission if an applicant fails to submit qualification certificates by the specified deadline, or if an applicant has provided false information.

Minimum score

The study programme available for application may have a set minimum score, meaning the minimum total score of the sum of scored subjects that the applicant has to reach in order to be selected.

Threshold criteria

To be selected in the certificate-based selection, applicants must have completed English advanced syllabus with the minimum grade C in their matriculation examination.

International matriculation examination

European Baccalaureate diploma (EB), International Baccalaureate diploma (IB) and Reifeprüfung (RP) diploma or Deutsche Internationale Abitur (DIA) diploma completed in Finland are scored similarly to the Finnish matriculation examination in certificate-based selection. Maximum score is 198 points.

The scoring model of the International matriculation examination is available on the UASinfo.fi website.

Equal score rules

If two or more applicants share the same total score, the rank order of applicants is resolved according to the following equal score rules:

1. Order of preferred study programmes
2. Matriculation examination grades:
 - I. Native language
 - II. Native language
 - III. Foreign language/second national language

If, for example, two applicants have received 100 points each and they both have the same order of preferred study programmes, the applicant with the better grade in native language will be selected. If both applicants have the same grade in native language, the second subject on the list is taken into consideration.

3. Overfilling/underfilling/drawing lots

If the criteria fail to produce a difference between tied applicants, SAMK admits all of the equally ranked applicants. SAMK may cancel admission if an applicant fails to submit qualification certificates by the specified deadline, or if an applicant has provided false information.

Threshold criteria

To be selected in the certificate-based selection, applicants must have completed English advanced syllabus with the minimum grade C in their matriculation examination.

SELECTION METHOD 2: UAS EXAM

The International UAS Exam is a written, joint digital entrance exam of Finnish universities of applied sciences (UAS), which is completed remotely with the applicant's own laptop. The International UAS Exam is used for selecting students to study programmes leading to a degree and conducted in English. The applicant takes the International UAS Exam only once, regardless of the number of study programmes targeted.

The International UAS Exam assesses the applicant's readiness for university of applied sciences studies. It does not include any pre-reading material or pre-assignments. The exam is conducted in the English language.

Language requirements: The applicants must demonstrate their English language skills by means of a language test or previous studies, in order to be invited to the International UAS Exam and selected through the International UAS Exam. Accepted tests, exams and degrees for proving English language skills are available on the UASinfo.fi website.

Identification & monitoring: The applicants have to identify themselves to the International UAS Exam and they are subject to real-time exam monitoring. Pre-identification has to be completed during a given time period. Only applicants who have successfully completed the pre-identification are invited to the exam. On the exam day, the applicants identify themselves while logging in to the exam. The applicants' activities during the exam will be monitored in the exam system.

Contents, duration and scoring of the UAS Exam: The International UAS Exam consists of different sections. The sections and the duration of the exam depend on the applicant's targeted study programme(s). For the International UAS Exam, a minimum pass score per section may be set. To be selected, the applicant must pass all the sections of the targeted study programme. The final selection of students is based on the applicants' results of the International UAS Exam.

Common sections to all study fields:

- Reasoning skills
- English language skills

In addition to the common section, the entrance exam may include the following study field-specific sections:

- Mathematical skills
- Advanced mathematical skills
- Ethical skills
- Emotional intelligence skills

More information on the International UAS Exam and more specific applicant instructions will be released during each joint application period on the UASinfo.fi website.

Please note that your exam scores will remain valid only for the application round in question.

The questions and the right answers of the exam will not be published. The International UAS Exam is deemed a secret official document based on the Act on the Openness of Government Activities, Section 24(22)

SELECTION METHOD 3: APPLYING WITH SAT TEST RESULTS

SAMK has a quota for applicants applying with SAT results. The SAT sections used in the admission are the following:

1. Evidence-Based Reading and Writing
 - Reading Test
 - Writing and Language Test
2. Math

The lowest score limit the applicant must reach in order to be qualified for the selection process is 400 per section, the minimum total score being 800. Only the new version of SAT test (completed after March 2016) is accepted. The SAT test selection only takes into account the sections performed during a single session.

Applicants must submit the SAT score to SAMK by 31 March 2025. The SAT score must arrive to SAMK Admissions directly from the College Board. Reports printed or submitted by the applicants themselves cannot be taken into account.

Applicants applying based on SAT must also demonstrate their eligibility to apply with their educational certificates and with proof of English proficiency.

Identification of the applicant

Valid and acceptable identification document (passport or EU/EEA identity card) is required in SAMK's separate application for identification of the applicant.

Accessible student admission – individual arrangements for entrance examinations

Evidence of language proficiency as part of admissions

Finnish language test

SAMK doesn't organise a Finnish language test or require result of any Finnish language test for admission.

English language proficiency

Good skills in English are required for success in degree programmes provided in English.

Proof of English proficiency is required in all the available degree programmes in SAMK. Applicants can prove their English language skills by the following documents:

1. English language test results:
 - IELTS Academic, IELTS Academic online and IELTS Academic UKVI: a minimum total score of 6.0 (Test sections: Listening, Reading, Writing and Speaking)
 - TOEFL Academic (iBT) and TOEFL iBT Home Edition: a minimum total score of 60 (Test sections: Reading, Listening, Speaking and Writing)
 - PTE Academic, PTE Academic online and PTE Academic UKVI: a minimum total score of 55 (Test sections: Speaking and Writing, Reading and Listening)
 - Cambridge English Scale Score: a minimum total score of 169 (Test sections: Reading and Use of English, Writing, Listening and Speaking)
 - TELC (The European Language Certificate) English B2-C1 university qualification, completed on or after 1 October 2021: minimum of B2 level (Test sections: Listening/Reading/Language Elements, Writing and Speaking)
 - Oxford ELLT (English Language Level Test), completed on or after 1 July 2023: a minimum total score of 6.0 (Test sections: Listening, Reading, Writing, and Speaking)
2. National Certificate of Language Proficiency (YKI) English, intermediate level, arranged by the Finnish National Agency for Education: Grade 4 or higher on all the subtests (speaking, listening comprehension, writing and reading comprehension).
3. Higher education degree completed in English in an EU/EEA country, Australia, Canada, New Zealand, Switzerland, United Kingdom, or the United States, or a doctoral thesis completed in English in any country. Please note that your degree must be taught and assessed entirely in English.
4. Upper secondary degree completed in English in an EU/EEA country, Australia, Canada, New Zealand, Switzerland, United Kingdom, or the United States. Please note that your degree must be taught and assessed entirely in English.
5. One of the following grades in the Finnish Matriculation Examination, European Baccalaureate, International Baccalaureate or Reifeprüfung/DIA completed in Finland:
 - Finnish Matriculation Examination: English advanced syllabus with a minimum grade C
 - International Baccalaureate diploma completed in English
 - DP Course Results or IB certificate completed in English (at least six subject groups)
 - International Baccalaureate final examination: English A HL/SL or English B HL/SL with a minimum grade 4
 - European Baccalaureate: at least grade 6.00 in L2-level English
 - Reifeprüfung/DIA diploma: at least grade 7 in advanced English
6. Applicants graduating in spring 2025:

Eligibility for Master's degree programmes

Eligibility for a UAS Master's degree programme is conferred by an appropriate UAS Bachelor's degree or another appropriate higher education degree and at least two years of subsequent work experience in a relevant field. As a relevant field is regarded both the field being applied to and the field of the previous higher education degree.
